- **1. CALL TO ORDER.** The Water and Sanitary Boards meeting was called to order by J. Auxer at 6:32pm at Town Hall in Shepherdstown, West Virginia.

- 6.d REPLACEMENT OF WATER LINE ROUTE 480 SOUTH (SHEPHERDSTOWN MIDDLE SCHOOL TO JANUS RESIDENCE). J. Ekstrom has submitted plans and the project should be ready for bid soon, as per F. Welch.
- **6.e** Water Plant HVAC system replacement. Two bids were received and C. Coe recommended that the bid from Shenandoah Air Conditioning and Heating be accepted.
