### 5. Unfinished Business

- a. Bane-Harris Park
  - i. Fence Repair

The fence has been replaced, but the poles were not replaced. Billy Grove contacted the Horst Fence Company, and they will replace about five posts.

ii. Basketball Net Replacement

Nylon nets are in use, but they are getting torn frequently. New rims may help.

Frank Welch will order heavy duty rims and backboards for both goals.

## d. Rumsey Park

i. Wall Repair - Concrete Caps

Wall on the back side of the Rumsey Monument needs repair of the concrete caps. Frank Welch will contact Gull Corporation to do the job. -- Pending

ii. Paint the new braces on the back of the sign.

#### e. Viola Devonshire Park

i. Tree Planting

Dead tree near the west fence will be replaced with a Japanese or French Lilac tree. Location is at the plaque for "Washington and Jenkins." Planting will be this winter by the Tree Commission.

ii. Mulch - Rototill mulch to remove weeds.

## f. Riverfront Park

i. Town Hall Approval

The "Riverfront Park" area east of the Town Run and boat ramp is now officially the Riverfront Park and is part of the Park System under the Parks & Recreation Committee.

ii. Sign

Approval of a sign for the Park by the HLC/Planning Commission. Cheryl Roberts will order the sign.

iii. Picnic Table Request

Approval of 8 to 10 picnic tables by the HLC/Planning Commission. Will start with three tables, coordinated with the zoning officer.

#### 6. New Business

Colin Voigt is concerned about the overgrowth of vegetation blocking the view around the Rumsey Monument. The Tree Commission will address this.

Mayor Jim Auxer will contact Rotary about general cleanup of the whole Rumsey Park.

Colin Voigt recommends that the Committee look at the Viola Devonshire b. Park entrance point from the Town Houses just east of the Park. A section of the metal railings would have to be removed.
