The Eastern WV Community Foundation administers the grants. Shepherdstown would have input on the grant guidelines. There EWVCF charges a 1% fee for this program. Moved by C. - c. CATF Economic Impact Study Chris Shaffer –Mr. Shaffer reported that the CATF previously received \$150K from the State and this amount is down \$50-\$60K. The purpose of the study is to gather input on attendees drive time, hotel accommodations, restaurants, and other activity ideas. The following organizations have been approached for assistance, Jefferson County Chamber of Commerce, Jefferson County Visitor's Center, Jefferson County Economic Development Authority. Moved by J. Ford to recommend to Town Council investment of \$5,000 for FY 17-18 and \$5,000 for FY 18-19 with the caveat that the Town Council gets a seat on the committee reviewing the firm proposals to ensure the Town has input. Unanimous
