- b. Halloween J. Ford stated no to endorsing Halloween as did C. Stroech.
  - C. Stroech we shouldn't sponsor any Halloween events.

    Mayor can't see endorsing Halloween and discourages it as well but it's up to individual households if they choose to have their lights on.
  - L. Robertson has concerns if the street is not closed and businesses still hand out candy, especially as the date falls on a Saturday. People will come in droves and it will be a hazard.
  - C. Stroech the Town Council does not endorse any Halloween events and Boofest and discourages any Halloween activities, including town-wide trick-or-treating based upon Covid-19 safety concerns. No objections noted.
- c. Christmas in Shepherdstown J. Haynes what do we do without having people gather? Shepherd University has said that McMurran Hall is off limits. Rotary can do a tree lighting, Judy and the mayor could still read.
  - C. Stroech the tree lighting and the readings will still draw a crowd.
  - L. Robertson is a no on the parade.

L. Robertson – move that we don't have the Christmas Parade, cancelling it the first week of December. No objections noted.

# C. Roberts – made a motion to close German Street for Santa the Friday after Thanksgiving. No objections noted.

Mayor – the council will help Deb Tucker craft a statement to encourage visitor's to come to Shepherdstown. Lighting the tree is beacon of hope. Let's let Christmas in Shepherdstown come up with ideas with limited or no gatherings.
