Hi Chris,

I reached out to your office about this stormwater drainage issue. I heard back from Debbie Henshaw. She said that I should contact you through the town council.

I have included an email chain that I had with the WVDOT after filing a formal request for road work through the WVDOT website. There's an area of high pavement between my driveway and the stormwater drain on the corner. My address is 101 S. Duke Street. I don't think the fix would require much funding or energy. I just want the DOT to mill the pavement down a little bit, but they don't seem to want to do this for me.

Before the recent paving in October, there was a vegetated ditch in front of my house. I asked the DOT to pave the ditch because they didn't do anything to maintain it. If I wanted water to flow past my house, I had to keep the ditch mowed and trimmed. Before the paving, if I stayed on top of the maintenance, I didn't get water in my basement. Since the paving, almost every large storm we have causes water to get into my basement. Any assistance with this issue would be greatly appreciated.

If the concrete sidewalk was continuous - drainage would not be on the sidewalk at the depressed driveway access. The concrete sidewalk is not graded properly. WVDOH standard details require a 6 inch thick slab at driveway accesses that has a 2 inch height on the pavement side. The 2 inches provides driveway accessibility plus provides a 2 inch curb height.

If the road is graded properly, then why is there a pool of water like this in front of my driveway? And why does the water not flow past my house to the storm water drain? You can see that the water is not flowing past my driveway. It stops at my driveway. You can see debris that has collected in the road just

past the pool water, because water hardly ever flows through there anymore except with major storm events.

Dear Debra Wenner,

Thank you for your email to the West Virginia Division of Highways (WVDOH) regarding S. Duke Street in Jefferson County. Your request has been forwarded to our District Five office for investigation and reply.

Please see attached pictures below. Picture Wenner01 shows your drainage concern prior to the paving project. The concrete sidewalk is flatter to accommodate driveway access at that location which causes water to pool, note the leaf line about halfway up the sidewalk. Your request at that time was to repair the drop inlet, remove the soil and grass to achieve better drainage toward the drop inlet, and pave that area. Mr. Welch, from the City of Shepherdstown, and I looked at the drainage infiltration concern in your basement and noticed that your gutters outleted in your yard close to your foundation. You had a contractor extend the gutters to outlet beyond your foundation (picture Wenner 04 - this gutter may still be contributing to foundation drainage). Additionally, Mr. Welch and I discussed your basement being below grade, foundation allowing infiltration of water, and the absence of any foundation drains.

You hired a contractor to replace the sidewalk in front of your house but failed to address the portion of sidewalk that was low and flat at the driveway access. On March 6, 2023 you sent an email and stated "I think the ditch in front of my house is worse since the sidewalk work. My contractors completely filled in the ditch, so that it is higher than my driveway."

Picture Wenner02 is a recent picture that you submitted showing the flat area of the sidewalk with a slight pool of water very similar to picture Wenner01. Picture Wenner03 shows the elevation difference of the pavement, sidewalk, and house.

Records indicate that you purchased this house in 2016. The house was built in 1930.

These are my findings: Water does not run uphill. Your house basement is below grade and has an inferior antiquated foundation that allows water infiltration. There are no foundation drains present. Surface water from your lot will drain into your foundation along with any subsurface drainage. As an owner of a home built in 1930 with a basement below grade you can expect additional maintenance responsibilities. There is nothing more that WVDOH can do to assist you.

If you desire to perform work on the pavement side of the sidewalk, WVDOH requires an encroachment permit with an approved and detailed plan. As you previously stated "hiring a contractor to put in a trench in the pavement in front of my house" is not an adequate plan and will not be approved.

Critics call out plastics industry over "fraud of plastic recycling"

Jan Dell is a former chemical engineer who has spent years telling an inconvenient truth about plastics. "So many people, they see the recyclable label, and they put it in the recycle bin," she said. "But the vast majority of plastics are not recycled."

About 48 million tons of plastic waste is generated in the U.S. each year; only 5 to 6 percent of it is actually recycled, according to the Department of Energy. The rest ends up in landfills or is burned.

Dell founded a non-profit, The Last Beach Cleanup, to fight plastic pollution. Inside her garage in Southern California is all sorts of plastic with

Davis Allen, an investigative researcher with the Center for Climate Integrity, said the industry didn't need for recycling to work: "They needed people to *believe* that it was working," he said.

A new report, called "The Fraud of Plastic Recycling," accuses the plastics industry of a decades-long campaign "...to mislead the public about the viability of plastic recycling," despite knowing the "technical and economic limitations that make plastics unrecyclable" at a large scale.

"They couldn't ever lie about the existence of plastic waste," said Allen.

"But they created a lie about how we could solve it, and that was recycling."

Tracy asked, "If plastic recycling is technically difficult, if it doesn't make a whole lot of economic sense, why has the plastics industry pushed it?"

"The plastics industry understands that selling recycling sells plastic, and they'll say pretty much whatever they need to say to continue doing that," Allen replied. "That's how they make money."

Plastic is made from oil and gas, and comes in thousands of varieties, most of which cannot be recycled together. But in the 1980s, when some municipalities moved to ban plastic products, the industry began promoting the idea of recycling as a solution.

Allen showed us documents and meeting notes they obtained from public archives, and from a former staff member of the American Plastics Council.

At a trade conference in Florida in 1989, an industry leader told attendees, "Recycling cannot go on indefinitely, and does not solve the solid waste problem."

In 1994 an Exxon executive told the staff of the plastics council that when it comes to recycling, "We are committed to the activities but not committed to the results."

Allen said, "They always kind of viewed recycling not as a real technical problem that they needed to solve but as a public relations problem."

The industry just launched a new ad campaign, called "Recycling is real," and says it's investing in what it calls advanced recycling technology.

The American Chemistry Council, an industry trade group, responded to "CBS Sunday Morning" in a statement, calling the Center for Climate Integrity's report "flawed" and "outdated," and says "plastic makers are working hard to change the way that plastics are made and recycled."

Jan Dell doesn't believe plastic will ever be truly recyclable: "It's the same process they were trying 30 years ago, and my response to that is, it's science fiction," she said.

Plastic production is set to triple by 2050, and with so much plastic waste piling up on land and sea, more than 170 countries are working on a United Nations treaty to end plastic pollution.

U.N. taking first step toward "historic" treaty on pollution from plastics, including "epidemic" of plastic trash

In a letter to President Biden about the negotiations, the plastics industry says it opposes any bans on plastic production, but supports more recycling.

To which Dell says, "The only thing the plastics industry has actually recycled is their lies over and over again."

PICK UP APPLIES TO TOWN RESIDENTS AND BUSINESSES ONLY!!!

One pick-up truck load per residence. All items are to be placed at the regular pick-up site. Please separate metal materials.

ACCEPTABLE FREE ITEMS: furniture, mattresses, household items, metal and yard waste.

<u>FULL OR PARTIALLY FULL PAINT CANS</u>: in order to be able to put paint cans out for Spring Clean Up, you must add a product call Krud Kutter Paint Hardener which is sold at Lowes and Home Depot. A container of 3.5 ounces cost about \$5.85 and will harden 2/3 gallon of paint. *Please leave lids off*.

- Items with Freon, such as refrigerators, air conditioners and dehumidifiers will be collected at a cost of \$50.00 per item.
- Passenger tires (under 15") will be collected at a cost of \$5.00 per tire. Passenger tire (over 15") will be collected at a cost of \$12.00 per tire.
- Televisions will be collected at a cost of \$40.00 each.
- The above-mentioned items must be reported and paid to the Billing Clerk at Town Hall, at 104 N. King Street prior to pick up.

PROHIBITED MATERIALS: propane/oil/gas tanks, compressed gas tanks, or any closed cylinders. Building materials, concrete, dirt/rock/sod, batteries, hazardous or dangerous materials, paint cans (*see note above*), medical/commercial waste and electronics.
